

NOTIFICTION

No. 86-SSE/11/ES/S/1A-01/2009. - 25th February, 2011. - WHEREAS the Right of Children to ree and Compulsory Education Act, 2009, hereinafter referred to as the said Act, has come into force with

AND WHEREAS section 3 (1) of the said Act envisages that every child of the age of 6 to 14 years all have Right to Free and Compulsory Education in a neighbourhood school till completion of Elementary

AND WHEREAS section 13 of the said Act has further provided that no school or person shall, while mitting a child, collect any capitation fee and subject a child or his/her parents or guardian to any screening ocedure and in the event of contravention of the said provision of law, such school or person collecting utation fees shall be liable to be punished with imposition of fines which may extend to ten times the capitation s charged and further that any school or person who subjects a child to screening procedure shall be liable be punished with fine which may extend to Rupees Twenty Five thousand for the first contravention and pees fifty thousand for each subsequent contravention;

NOW, THEREFORE, in exercise of the powers conferred under section 35 (2) of the Act the Governor been pleased to direct that no School authority including any recognized Government, Government Aided or uded Educational Institution or any person attached to any such school shall, while admitting a child, collect capitation fees as defined under section 2(b) of the Act or subject the child or her / his parents to any ening procedure. If the number of applications for admission to a particular school exceeds the number of lable seats, the school shall determine the students to be admitted by conducting open lottery.

The Governor is further pleased to direct that any violation of this direction shall be punishable under se (a) of sub-section (2) of section 13 of the said Act. Any affected guardian of any child or any person sted coming under the purview of this Notification may lodge a written complaint before the District

Magistrate of the concerned District (Commissioner, Kolkata Municipal Corporation for school located within the territorial jurisdiction of Kolkata Municipal Corporation) or the concerned District Inspector of Schools and any of these authorities having received any such complaint shall, within a period of 60(sixty) days, shall cause an enquiry into the complaint and forward such enquiry report along with his recommendations to the Director School Education, West Bengal. The Director School Education West Bengal shall, within a period of 45 days from the date of receipt of such report, decide on imposition of fine or otherwise on the school authority or person after giving an opportunity of hearing to such school authority or person. In case the Director School Education decides to impose fine under the provisions of the said Act he shall also specify the amount, manner, the time limit and the head of account under which such fine is to be deposited by the school authority or person. Any school authority or any person affected by such order may submit an appeal in writing to the Secretary, School Education Department, Government of West Bengal within a period of 30 (thirty) days from the date of the order and the Secretary, School Education, Government of West Bengal shall dispose of such appeal within a further period of 30 (thirty) days.

NOTIFICATION

Whereas a good number of complaints have been received by the School Education Department against the prevailing system of lottery conducted in Government-run-Schools in connection with selection of candidates for admission of students in elementary classes;

And whereas students belonging to reserved category are reportedly being deprived of their

legitimate privileges by such process of lottery.

Now, therefore, the Government is pleased to introduce separate sets of lotteries as per mode stated hereunder.

At first a general lottery from among all applications irrespective of any category to find i) out the selected general candidates.

A second set lottery for left over candidates in each category i.e. separate lottery for the left over SC candidates, separate for left over ST candidates and separate lottery for left over OBC candidates to select the candidates from the reserved quota in each category.

This will be effective form the next academic session i.e. 2012 in all Govt. / Govt. aided schools across the State of West Bengal for admission of students in elementary classes.

CIRCULAR

In accordance with the approval of Mon'ble Minister in Charge, dated: 13-10-2011, a new system of conducting lottery for admission at the elementary level of all Govt./Govt. Sponsored Schools is being introduced from the academic year, 2012. The process of conducting lottery will be as follows:

The respective Schools at the District Head Quaters/Kolkata Zone will form a Committee comprising following member, who will conduct the lottery as per prevalent guidelines of the Govt.:

- a) Chairperson of D.P.S.C. of the Concerned District: C h a i r m a n.
- b) Headmaster / Headmistress of the Concerned School(s) : Member Secretary and Convenor.
- c) D.I. Primary of the Concerned District: Member.
 - d) Representative of the District Magistrate for the district D. S. E. for Kolkata: M G m b g r

In case of Govt. Schools located in Sub-divisional towns or town other than the District Head Quarters or Sub-divisional Headquarters, the Committee will comprise the following: ...

- a) Chairperson of D.P.S.C. of the Concerned District : Chair
- b) Headmaster / Headmistress of the Concerned School: Member Secretary and Convenor.
- c) D.I. Primary of the Concerned District: Member.
- d) Representative of the local Sub-divisional Officer: Memb

In case of Govt. Schools the lottery will have to be conducted in a decentralised manner for each School separately by maintaining the norms of admission and reservation properly in terms of Govt. Order vide No.: 628-SE(Pry.)/10M-185/2010, dated: 12-10-2011.

All Govt. Sponsored Schools in the State will conduct the lotter at the elementary level of admission through their respective Managing Committee in accordance with the prevalent guidelines of the Government reservation schedule in terms of Government Order referred above.

The Admission forms will be distributed free of cost and total expenditure for conducting lottery is to be met from Contingacy Fund.

The process of admission through lottery must be completed by al Schools well ahead the date of commencement of the Academic Session.

All Concerned are being informed accordingly.

With reference to the above I am directed to inform you that the issue in question was discussed in Cabinet meeting held on 16/11/2011 and it has been decided that lottery system for the purpose of admission of students in elementary classes for the academic session, 2012 will be

I am therefore, further directed to inform you that the order issued vide this Deptt. No. 628-SE (Pry)/10M-186/2010 dated 12.10.2011 shall stand valid and to be followed meticulously regarding admission of students for the academic session, 2012. Moreover, I am directed to say that in case where a school has both Primary and Secondary section, there will no lottery for students already admitted in the primary section. In case there are any excess seats after admission of existing students only then there may be a lottery at class-V for filling up the additional seats.
